Remember that you have to show your return flight ticket at the Police Control, before entering to Easter Island.

Those who provide spurious information or falsified documentation, or conduct a contract or allege an in-fact situation in order to bypass the provisions of Law No. 21.070 could be sanctioned with fines between 20 to 30 UTM, additional to the penalties that correspond for crimes contemplated in the Criminal National Code and other laws.
