

Declaración Jurada Digital para el ingreso a Chile/ Digital Affidavit to enter Chile/Declaração Digital de entrada no Chile

De acuerdo con la **Ley Chilena**, toda persona mayor a 18 años debe completar la Declaración Jurada para el ingreso a Chile. Esta declaración debe incluir la de los menores de edad que viajen a su cargo. No se arriesgue, declare, y si tiene alguna duda, realícela a un/a inspector/a antes de la revisión.

According to **Chilean Law** every person over 18 years of age who enters Chile must fill out the Affidavit. This statement must include that of minors traveling under their care. Do not take risks, declare, and if you have any doubts, ask an official before the inspection.

De acordo com a **Lei Chilena**, todas as pessoas maiores de 18 anos de idade que entram no Chile devem preencher a Declaração. Esta declaração deve incluir a de menores viajando sob seus cuidados. Não se arisque, declare, e se tiver alguma dúvida, pergunte a um agente antes da inspeção.

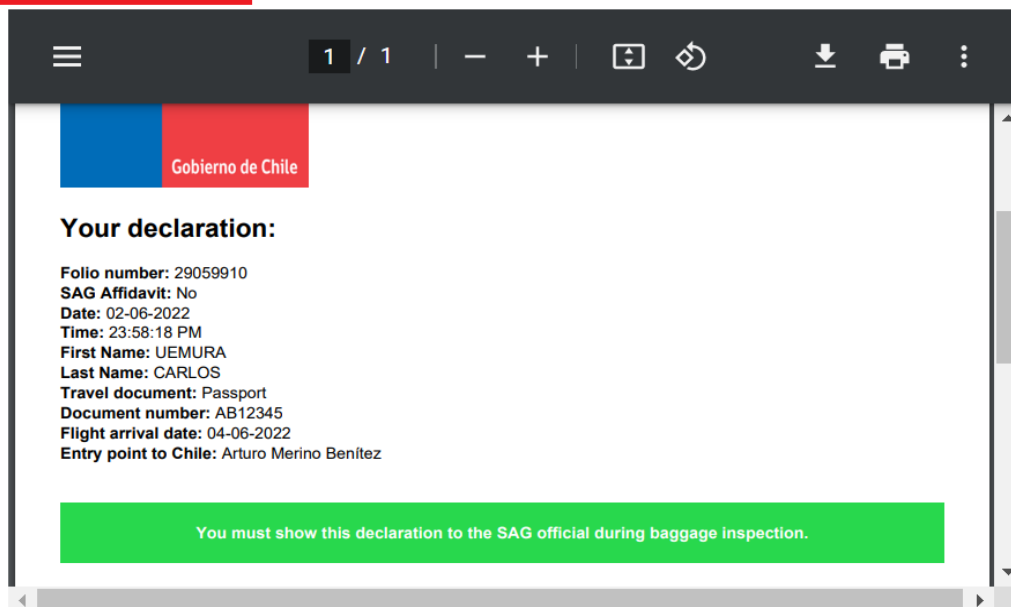
